Dube TradePort Corporation (DTPC) is a Schedule 3C provincial public entity mandated with the development of the Dube TradePort precinct. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

DTPC has the IMPRO system which controls access to persons and vehicles via automated booms, turnstiles, door locks etc.

DTPC hereby invites suitably experienced and IMPRO accredited service providers to provide proposals for the maintenance of the access control system in the form of version updates, system maintenance, hardware and software repair/replacement, system support/training, rezoning for groups etc. for a period of three (3) years.

The contract will have an element of Enterprise Development of a minimum of 15% of the contract value to be executed by historically disadvantaged companies who are 51% or more black owned. The ED element is designed to assist with the development and sustainability assistance of black companies (i.e. EME and QSE) through contract participation and development in the contract.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10.
