Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC invites proposals from suitably experienced and qualified service providers to provide Quarterly, Bi-Annually and Annual service to all its fire detection and fire protection equipment for a period of three (3) years.

The service and maintenance of the equipment includes the following:

- Fire Extinguishing Equipment (Fire Extinguishers, Hose Reels and Gas Suppression System);
- Fire Detection Equipment (including Fire Control Panels);
- Fire Ventilation Systems located at DTPC precinct;
- The Maintenance of Automatic Sprinkler Systems, and Hydrant Control Valves and Reticulation; and
- The Maintenance of Automatic Sprinkler Systems and Hydrant Booster Pumps and Control Panels

Servicing of fire protection must be in accordance to Government Legislature and Regulations i.e. South African Qualification and Certification Committee for the Fire Industry – SAQCC, and ASIB.

In line with the PPPFA regulations 2017, sub regulation 4 the prequalification for this bid is that **only** EME/QSE companies are eligible to tender.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
