Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC would like to appoint a competent Service Provider to operate and maintain the Water Treatment Works at the AgriZone.

The service provider will ensure that the AgriZone Water Treatment Works (AWTW) is operated and maintained at an optimal working standard. The services will include effective proactive, predictive, corrective and preventative programmes be followed to minimise reactive maintenance and related breakdown costs.

The specific services required shall include, but not limited to the following:

- Process operation of the AWTW
- Supply of RO chemicals,
- Maintenance / servicing of AWTW, and
- Conducting of CIP process on the RO membranes and management of the resultant chemical waste.

During operation and maintenance period, an appointed service provider shall ensure the following but not limited to:

- The operational integrity of the AWTW;
- The replacement of components before they fail or when they are no longer able to deliver a reliable and effective equipment operation;
- The reliability of the plant performance;
- The plant is kept safe, clean and presentable at all times; and
- Maintenance of AWTW as per the agreed contract to be signed with DTPC.

In line with the PPPFA act as well as the regulations, 2017 the prequalification for this bid is that **only** companies who meet the following are eligible to tender:

- a) Companies who are B-BBEE Level 1 or 2 or 3 or 4 status; or
- b) Any company who sub-contract at least 30% to a black owned EME/QSE Company.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
