Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC invites proposals from suitably qualified Professional Consulting Engineering service providers to assist DTPC with the implementation of various Civil and Infrastructure Projects for a period of three years.

DTPC will appoint six (6) service providers to form a panel of Civil Engineering and Infrastructure Consultants, respectively.

 Specific work will be allocated on a project basis as per DTPC requirements, processes and needs.

In line with the PPPFA act as well as the regulations 2017, the prequalification criteria for this bid is that only companies who meet with the following are eligible to tender:

a) Only BBBEE level 1 or 2 with 30% sub contracted to black EME/QSE.

#### Clarification note:

(In the case of a JV / Partnership, bids from JVs / Partnerships must produce a consolidated B-BBEE Certificate in accordance with this requirement).

#### **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 or 90/10 preference points system.
