DTPC wishes to appoint a suitably qualified contractor(s) who is registered for CIDB grading 5 CE/GB or 4 CE/GB PE or higher for the construction of a Water Laboratory and associated site works.

The work to be carried out under this contract includes the construction of the following, but is not limited to:

- 100m² laboratory
- 1770m² asphalt surfaced access, parking and circulation area
- 150m sewer reticulation
- 150m water reticulation
- Stormwater reticulation
- Electrical reticulation
- Minor earthworks

The project will have an element of enterprise development as per the bid document.

EVALUATION OF THIS BID:

All proposals will be evaluated in various stages including compliance, functionality and price in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
