## REQUEST FOR PROPOSALS for the CONSTRUCTION OF BULK EARTHWORKS at TRADEZONE 2 Located at DUBE TRADEPORT

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

DTPC intends to develop TradeZone 2 through the provision of bulk earthworks and stormwater management infrastructure. The proposed construction site is located adjacent to TradeZone 1 at Dube TradePort. The scope of the project includes the construction of the mass earthworks of the TradeZone 2 earthworks platform which consists of the mass hauling of a significant amount of material which is to be sourced from the site.

Proposals are hereby invited from competent civil engineering contractors who are registered for CIDB grading 9 CE. The project will have a component of enterprise development or Contract Participation Goal equaling 15% of the contract value.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages including compliance, functionality and price in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
