DTPC invites proposals suitable experienced and authorized reseller of either the Original Equipment Manufacturers (OEMs) a distributors of (Ubiquity, Cisco, Mikrotik, APC, and Raritan) to supply DTPC with Data Center and Network operational spares on an adhoc basis for three years.

This is to support DTPC by providing replacement for hardware which is out of warrantee as well as stock which is to be used to provide services to new buildings.
