

# REQUEST FOR PROPOSALS FOR THE INSPECTION AND MAINTENANCE OF POND COVERS AND LINERS AT THE AGRIZONE WITHIN DUBE TRADEPORT PRECINCT FOR A PERIOD OF THREE (3) YEARS

DTPC wishes to appoint a competent Service Provider to undertake inspection and maintenance of pond covers and liners at the AgriZone precinct. The scope includes yearly inspection and maintenance, once-off major maintenance and ad-hoc repairs of the pond covers and liners with associated ancillary components.

Proposals are hereby invited from competent Service Providers to execute inspection and maintenance of the floating covers and High Density Polyethylene (HDPE) liners of the ponds located at the AgriZone precinct

It is a condition of this bid that the tenderer must subcontract a minimum of 35% to an EME.

### **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
