Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC invites proposals from suitably qualified, experienced and independent professional service providers to provide technical services in the acquisition of projects in the Mechanical Engineering and maintenance field for its Bid Specification Committee (BSC) and Bid Evaluation Committee (BEC).

The services include the following but not limited to:

- Market research on each proposed project;
- Attendance at BSC and BEC meetings;
- Complete final specification document for each project/service being procured;
- Bid Specification Committee Close out report;
- Summary review of each compliant tender response contained in a Technical Report for procurements less R10 million;
- Technical capability statement and risk assessment report of each compliant bid for all procurements in excess of R10 million;
- Attendance at quarterly report back session; and
- Any other ad hoc deliverable as may be required for specific procurements.

In line with the PPPFA regulations, 2017 sub reg. 4 (b), the prequalification criteria is that **only** companies who are EME or QSE are eligible to tender.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.

REQUESTS FOR DOCUMENTS & ENQUIRIES

Bid documents will only be available from, 20th August to 27th August 2018 during the weekdays (Mon – Fri) between 08h30 and 16h00, at the Dube TradePort Corporation offices at 7 Umsinsi Junction, 4th floor, 29° South, La Mercy, KwaZulu-Natal.
