- Assist with providing general built environment engineering and project support to the Dube TradePort Planning and Infrastructure team
- Preparation of feasibility studies and budgets for proposed projects,
- Technical evaluation of designs
- Provide specialist advice on engineering matters
- Assistance with dealing with contractors and resolving contractual issues
- Preparation of high level concept designs
- Provision of any other relevant engineering and related work, as and when required

(a) Bidders must be at least 51% Black Owned EME or QSE Companies
