Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC invites competent and experienced contractors who are registered with **CIDB grading of 3ME** or higher to tender for remedial/**rectification work to the HVAC System** at the Dube TradePort Cargo Terminal.

The purpose of the exercise is to conduct remedial/rectification work to the existing HVAC system at Dube Cargo Terminal to ensure alignment with original specifications and standards and further ensure environmental sustainability through energy efficiencies. The work will consist of, but is not limited to, the engineering, manufacturing, supply, delivery, offloading, erection, testing balancing and commissioning into service, guarantee and maintenance of the HVAC system as described in the bid document.

EVALUATION OF THIS BID:

All proposals will be evaluated in various stages including compliance, functionality and price in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
