To render pest control management services by preparing and implementing a comprehensive Integrated Pest Management Plan (IPMP) for the DTPC, for a period of 3 years.

The scope of work will include, but is not limited to Preparing and Implementing a Comprehensive Integrated Pest Management Plan (IPMP), maintaining existing pest control equipment and providing innovative solutions for all-inclusive general pest control management within the DTPC.

EVALUATION OF THIS BID:

All proposals will be evaluated in various stages including compliance, functionality and price in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
