Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC intends to develop TradeZone 1B through the provision of a new intersection and access roads; municipal services including potable and fire water supply infrastructure, sewer drainage infrastructure, stormwater drainage infrastructure, and bulk earthworks. The proposed construction site is located to the north of TradeZone 1 across Watson Highway at Dube TradePort.

Tenders are hereby invited from competent civil engineering contractor(s) who are registered for CIDB grading 7 CE or higher by the closing date of tenders. The project will have an element of enterprise development as per the bid document.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages including compliance, functionality and price in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
