Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

The AgriZone has six (6) covered irrigation ponds that need to be maintained. DTPC invites service providers to execute maintenance on the floating covers and liners of the ponds for a period of three (3) years. The service required includes yearly inspection, ad-hoc repairs and major maintenance of the floating pond covers and linings. The ponds range in size from 500m<sup>3</sup> to 23 000m<sup>3</sup> with a total of 70 000m<sup>3</sup>.

## **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
