DTPC wishes to enter into a three year maintenance contract with a suitably qualified and accredited Service Provider(s) who are registered with Retail Motor Industry (RMI) or having similar accreditation who will ensure that the DTPC vehicles (i.e. Toyota, VW, Hino, Multiservice (water tanker), Mercedes, Nissan, Titron (trailer) and Tata are maintained at optimal working standards. Effective proactive, predictive and preventative programmes must be implemented to minimise reactive maintenance. The contract must include vehicle maintenance, servicing, repairs and vehicles wash facility. The contract may be awarded to multiple Service Providers.

## **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 80/20 preference point system where 80 points will be reserved for price only and 20 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
