DTPC is seeking to appoint a suitable qualified service provider to install a cloud management software solution and to support it for a period of three years. The installation must include integration with the existing VCE (VMWare, CISCO, and EMC) stack and the future Microsoft Hyper-V to provide a single pane of glass for management.

The cloud management software solution must at a minimum contain the following capabilities:

- Public self-service portal
- Provisioning
- Reporting
- Monitoring
- Billing
- License Management

All proposals will be evaluated in the following stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
