Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC requires a service provider to provide a solar photovoltaic system which will supplement DTPC services within TradeHouse. The solar panels are to be placed on the existing roof structure of the TradeHouse within Dube TradePort. The approximate area of the TradeHouse roof is approximately 8800m² with an estimated 4400m² available for panel installation.

DTPC wishes to appoint a competent service provider to design, supply, install, commission and maintain a new solar photovoltaic system at the TradeHouse within the TradeZone at Dube TradePort. National Treasury Instruction Number 2 of 2016/2017 – Local Production content for Solar Photovoltaic systems and components applies.

The contract will have an element of Enterprise Development (ED) with a minimum of 35% sub-contracted to historically disadvantaged companies who are at least 51% black owned.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages in accordance with the PPPFA regulations, 2017 using the 80/20 preference point system.
