

**CALL FOR PROPOSAL (CFP) FROM PROSPECTIVE OPERATORS FOR THE LEASING AND OPERATION OF THE EXISTING TAKE-AWAY AND RESTAURANT FACILITY (“AGRIZONE CANTEEN”) SITUATED AT THE DUBE AGRIZONE**

**DUBE TRADEPORT CORPORATION, (HOME OF KING SHAKA INTERNATIONAL AIRPORT), LA MERCY KZN**

Dube TradePort Corporation (DTPC), a provincial public entity (Schedule 3C in terms of the Public Finance Management Act) is a multi-modal development situated 30 kilometres north of the Durban city centre.

This is an invitation to prospective operators to submit proposals for the leasing and operation of this purpose built Takeaway and Restaurant Facility (the “AgriZone Canteen”) located within the Dube AgriZone in the Dube TradePort.

The AgriZone Canteen is an existing purpose built canteen facility situated in the Dube AgriZone. The area around the Dube AgriZone is still in development stage and as a result, the exact numbers of staff and contractors is not guaranteed by DTPC. It is estimated however that there are approximately 120 people that currently work in the proximity of the facility with a potential to grow to 200 people and is expected to increase gradually over the next few years.

The successful operator will be responsible for obtaining all necessary permits and licences prior to operating the facility.

Proposals for the Leasing and operation of the AgriZone Canteen must be submitted at the **DTPC** offices on or before **15H00**, South African time on the **05<sup>th</sup> November 2019** to qualify for the evaluations.

Further proposals will be accepted post **05<sup>th</sup> November 2019**; however, these proposals will be assessed on condition that no suitable proposal is received by the first closing date (**05<sup>th</sup> November 2019**).
