Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC invites tenders from competent building contractor(s) for the construction of a Technical Facility in the AgriZone Precinct located at DTP. The works include, but are not limited to, the construction of technical facility building approximately 330m², and associated services. The proposed technical facility will be connected to an existing greenhouse. The technical facility structure will include the following:

- Open plan office including circulation
- Canteen with adjoining kitchenette.
- Male and Female Ablution Block with Change room facilities
- Chemical store
- Cold Room
- 3 Storage Areas with associated loading area
- Parking and loading area including awning structures

To be eligible to tender, Contractor(s) must be registered with CIDB grading 5GB or higher and Contractor(s) is required to achieve a minimum of 10% Contract Participation Goal (CPG) to comply with DTPC's tender requirements.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
