DTPC wishes to enhance their Geographic Information System (GIS) Database and spatial data collection and management capabilities. Furthermore, DTPC would like to improve the spatial data sharing with its employees and relevant internal and external stakeholders by acquiring GIS server software and the development of a customised DTPC GIS web-portal. DTPC operates the Esri ArcGIS software as its GIS software suite.

This project will be delivered in two phases which will run parallel to each other:

- Phase 1: The successful service provider will cleanse and maintain the existing data sets; and
- Phase 2: The service provider will install the new server software, migrate the cleansed data, develop and implement a customized DTPC GIS web-portal.

The contract will have an element of Enterprise Development of a minimum of 15% of the contract value to be executed by historically disadvantaged companies who are 51% or more black owned. The ED element is designed to assist with the development and sustainability assistance of black companies (i.e. EME and QSE) through contract participation and development in the contract.
