### THE PROVISION OF AUTOMATIC VOLTAGE CONDITIONER (AVC) AND POWER FACTOR CORRECTION (PFC) INSTALLATION AT AGRIZONE

Dube TradePort hereby invites proposals from suitably qualified and experienced service providers to design, supply, install and commission a new Dynamic Power Factor Correction Unit and an Automatic Voltage Regulator Unit for AgriZone. These services will include but not limited to:

- Installation of temporary Power Quality Metering
- Supply of Power Quality Filter 150kVar
- Supply of Power Voltage Conditioner 260kVA

In line with the PPPFA regulations, 2017 sub reg. 4 (1), the prequalification criteria for this bid is that **only companies which are B-BBEE Level 1 or 2 or companies subcontracting at least 30% to an EME are eligible to tender for this bid.**

#### EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
