Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

DTPC requires the services of a suitably qualified service provider to provide the design, supply, maintenance and support for a period of three (3) years.

The services must include, but are not limited to:

- Compute Resources and Storage infrastructure;
- Development and Testing Workloads;
- Disaster Recovery;
- Backup Storage;
- Archive Solution;
- Professional Services, Maintenance and Support;
- Migration & Integration into Dube iConnect Services ; and
- Licensing

In line with the PPPFA regulations, 2017 sub regulation 4(1), the prequalification criteria for this bid is that only companies who meet with following are eligible to tender:

- i) Bidders with B-BBEE Level 1 or 2; or,
- ii) Subcontracting 40% to a Black EME or QSE company.

Bids submitted by companies not meeting one of the above requirements will not be accepted.

### VALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
