Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to <u>www.dubetradeport.co.za</u> for more information on DTPC.

DTPC invites tenders from competent civil engineering contractor(s) who are registered for **CIDB** grading 9 CE for the construction of the AgriZone 2 bulk earthworks and services (Civil and Electrical). DTPC intends to develop AgriZone 2 through the provision of the following infrastructure:

- Mass Earthworks
- Access Roads and Internal Roads
- Attenuation and retention ponds for storm water management
- Internal water reticulation
- Internal sewer reticulation
- Electrical reticulation
- Fire water pipeline reticulation
- Gatehouse construction
- Perimeter fencing
- Storm water reticulation, inclusive of different arrangements in order to optimise Storm water control and re-use
- Pedestrian walkways
- Landscaping, etc.

The pre-qualification criteria for the bid is that at least 35% of the value of the Contract (calculated before VAT) **must be sub contracted** to Black Owned Exempted Micro Enterprises (EMEs) or Black Owned Qualifying Small Business Enterprises (QSEs) who are registered and have an active **CIDB Grade 6 or lower**. The objective criteria is that all CPG partners must be located in KwaZulu Natal (KZN) and have their operating offices in KZN.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 90/10 preference points system.
