Dube TradePort Corporation hereby invites proposals from accredited and qualified service provider who are **Gold Microsoft Partnership certified** as a minimum requirement to provide Active Directory Upgrade, Microsoft Exchange 2016 upgrade and provide maintenance and support for all Microsoft products for DTPC for a three (3) year period.

The appointed service provider will be required to provide, inter alia, the following services but not limited to:

Upgrade and Maintenance

- Upgrade the current DTPC's Active Directory Forest Infrastructure to version 2016. In addition to perform the hardening activities needed.
- Upgrade current email and collaboration system (Exchange 2010) to Exchange version 2016, in order to leverage the latest capabilities.
- Upgrade the SQL version 2010 to version 2016.
- Upgrade Sharepoint Server version 2012 to version 2016 and migrate the data.
- Upgrade the Windows Server platform from version 2012 to version 2016.
- Conduct Infrastructure analysis for version 2019 or latest and application readiness.
- Upgrade from version 2016 of the Active Directory Forest Infrastructure to version 2019 or latest. In addition to perform the hardening activities needed.
- Upgrade current email and collaboration system (Exchange 2016) to Exchange version 2019 or latest, in order to leverage the latest capabilities.
- Upgrade the SQL version 2016 to version 2019 or latest.
- Upgrade Sharepoint Server version 2016 to version 2019 or latest and migrate the data.
- Upgrade the Windows Server platform from version 2016 to version 2019 or latest.
- Upgrade SCOM and SCCM from version 2016 to version 2019 or latest;
- Roll out of Microsoft Office 365 to 50 Users;
- Provide maintenance and support to the above

In line with the PPPFA regulations, 2017 sub regulation 4 the prequalification for this bid is that is the following:-

• Only B-BBEE Level 1 or 2 companies which are subcontracting 45% to EME/QSE companies which are at least 51% black owned; or EME/QSE companies which are B-BBEE Level 1 are eligible to tender for this bid.
