In line with the PPPFA regulations 2017, sub regulation 4, the prequalification for this bid is for bidders to meet the following:-

1. The main bidder must have B-BBEE Level 1 status and the main bidder must sub contract 40% to a Black Youth Owned company or Black EME/QSE company.

OR;

2. Only B-BBEE Level 1 who are EME/QSE are eligible to tender.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
