Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

DTPC invites tenders from competent building contractor(s) for the construction of a Maintenance Facility (Approx. 380 sqm) for Dube TradePort located at the TradeZone within Dube TradePort. The works include, but are not limited to; Building works, Electrical Works, Mechanical Works, Civil Works, and Plumbing/Wet Works.

To be eligible to tender the Contractor(s) is required to achieve a minimum of 10% Contract Participation Goal (CPG) to comply with DTPC's tender requirements.

The contractor(s) must be registered with CIDB grading 6GB or higher.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
